

What is renewable Lesotho?

Renewable Lesotho brings together a toolbox of instruments, including: Infrastructure development: supporting a pipeline of projects ranging from off-grid solutions, mini-grids, solar home systems, to potential larger investments in hydro-, solar, including floating solar, wind energy, and transmission.

How much hydropower does Lesotho generate?

Currently, Lesotho generates 72 megawatts of hydropower through the 'Muela Hydropower plant, which does not satisfy domestic demand. The country will generate 80 MW following the construction of the Polihali Dam expected to be completed in 2028. There is potential, and there are plans, to expand hydropower capacity and establish wind farms.
