

Who owns Solarcentury?

Credit: Statkraft. Norwegian state-owned renewable energy company Statkraft has announced its acquisition of UK solar panel manufacturer Solarcentury. The wind power market has grown at a CAGR of 14% between 2010 and 2021 to reach 830 GW by end of 2021.

Will Statkraft buy Solarcentury?

Norwegian renewables giant Statkraft is to acquire UK-headquartered solar developer Solarcentury, taking on a 6GW global portfolio in doing so.

Will Solarcentury become a world-leading solar developer?

The company also added that Solarcentury's geographical footprint matched that of Statkraft's existing development portfolio and market operations. Furthermore, Statkraft said the deal would make the company a leading developer within Europe's solar market, with the potential to become world-leading.

Who is Solarcentury?

Having acquired solar pioneer Solarcentury in November 2020, our highly skilled solar development team operates across Europe and Latin America with a global pipeline of over 6.5GW, positioning us as a major developer in the European solar market.

Why did Solarcentury sell?

Confirming those reports, Solarcentury CEO Frans van den Heuvel told sister publication Solar Power Portal that a sale was necessary to propel the company to the "top tier" of global solar development.

How did Solarcentury make a profit in 2019?

In 2019 Solarcentury announced an eightfold increase in annual profits to €14.4 million, largely due to constructing and operating unsubsidised solar farms in southern Europe, Latin America and Africa.
