31 October 2022 - BIG Energia Holdings won a tender for a combined wind and solar project in BiH and signed a lease for land in Romania for a PV plant. North Macedonia. BIG Shopping Centers buys 70 MW solar power project in North Macedonia.

BIG Energia Holdings will develop the wind and solar project in Bosnia in partnership with Israel's Mega Or Holdings and through a local company. The power plant is envisaged to be built on state-owned land. It will comprise an 80 MW solar park and a 40 MW wind farm. The cost of development and construction will be approximately EUR108mn.
