Brazil is one of the leading countries in hydroelectric power generation, trailing China. The growth of power companies in the country is surprising, as is the development of Enel, one of the largest energy companies in Brazil, now a leader in the Brazilian electrical power industry.

What did Brazil energy do in 2008?

In 2008, Brazil Energy decided to expand its operations to other power generation sources, creating two new companies: Brazil Biomass Energy S.A. (BBE), focused on power generation from biomass, and Brazil Hydropower S.A. (Brazil Hydro), focused on hydroelectric power.

How much energy does Brazil use a year?

The data collected by the CCEE also show that Brazil demanded an average of 66,751 megawatts in January, a reduction of 0.7% in energy consumption. This was due to a change in the Regulated Market (ACR) that supplies energy to small businesses and homes. The average consumption by such industries was 44,228 MW, 3.2-percent down year over year.
