

Who is Dolphin Energy Limited?

Dolphin Energy Limited was established in March 1999 as an initiative of the Government of Abu Dhabi. From the beginning,its founders conceived Dolphin Energy Limited as a force for international energy cooperation that would unite the vision and resources of the region with multinational capital and expertise.

Who imports the fuel in Cook Islands?

85% of the country's fuel and all of its jet fuel is imported by Pacific Energy. The Energy Act 1998 established an Energy Division within the Ministry of Works,Energy and Physical Planning (now Infrastructure Cook Islands) responsible for energy policy and electricity inspections.

Does Dolphin Energy Limited work from home?

In 1999, the government of Abu Dhabi established Dolphin Energy Limited to implement a unique strategic energy initiative that began production in 2007. In line with government directives, Dolphin Energy Limited has instructed its employees in the UAE to work from home until further notice.

How much energy does the Cook Islands use?

The Cook Islands is a net importer of energy,in the form of petroleum products. Total energy consumption was 1,677,278,000 BTU (1.77 TJ)in 2017,of which 811,000,000 (0.86 TJ) was in the form of oil. In 2012 47% of imported oil was used in the transport sector,30% in aviation,and 27% for electricity generation.

What sectors rely on imported energy in the Cook Islands?

There are three main sectors dependent on imported energy in the Cook Islands; these include transport,electricity and aviation. Of the total number of imported fuels into the country,43% is used by transport; 30% by aviation and 27% by electricity.

What changes will the Cook Islands make?

The changes will include management of power utilities, environmentally friendly and cost effective renewable electricity sources, and energy efficient strategies. The Cook Islands will be careful in its selection of renewable electricity options and will not entertain unproven or non-commercial technologies.
