

What is the EU energy support package for Montenegro?

The EU energy support package for Montenegro, worth EUR30 million, was officially launched at a ceremony in Podgorica on Wednesday, 8 March.

Does Montenegro have a national energy and climate plan?

Montenegro is still finalizing its draft National Energy and Climate Plan (NECP). Montenegro has not defined the 2030 climate target in its national legislation, nor in the draft NECP. It should align with the 2030 targets set by the Energy Community. There is a legal basis for the national inventory system.

How will EU funds help Montenegro?

The EU funds will be used to help the most vulnerable groups in Montenegro to cope with the higher living costs caused by the Russian war of aggression against Ukraine, but also to facilitate the country's transition to green energy.

Which energy projects have been subjected to an EIA in Montenegro?

Montenegro has not provided a list of energy projects that underwent screening and were subjected to an EIA. The development of the EIA, which should include an appropriate assessment for the Komarnica hydropower project, located within a candidate Emerald Site and the Dragi?nica and Komarnica Nature Park, was delayed.

Does Montenegro have an energy efficient home?

In 2023, the project Energy Efficient Home continued to support households to purchase heat pumps with interest-free loans. Montenegro is still finalizing its draft NECP, which must harmonize the 2030 energy efficiency targets with the 2030 targets set by the Energy Community.

Does Montenegro have a gas market?

Montenegro does not have a gas market. REMIT Regulation (EU) 1227/2011 is in place. Despite the non-existing gas market, Montenegro adopted the supply rules for natural gas. Initially scheduled for 2019, the adoption of the new Law on Cross-Border Energy Infrastructure projects, intended to transpose Regulation (EU) 347/2013 is pending.

The EU and EBRD have signed a Reform Facility agreement worth EUR2.5 million to help Montenegro with energy security, investment climate and corporate governance of state-owned enterprises. The EBRD will support enhancing the regulatory framework promoting renewable energy and the integration of Montenegro's power market into the EU and regional ...

Montenegro has asked for exemption from the EU Carbon Border Adjustment Mechanism (CBAM), a tariff on carbon-intensive goods, which the European Union will introduce in January 2026, energy minister Sasa Mujovic said, as cited by local media.

Montenegro is set to become part of the trans-European energy networks aimed at enhancing energy exchange among EU member states. The section of the Trans-Balkan Corridor passing through Montenegro includes the 400 kV transmission line Lastva - Pljevlja and the Pljevlja - Bajina Ba?ta transmission line.
