

In a disclosure to the Philippine Stock Exchange yesterday, AC Energy Corp. (ACEN) said the company and its subsidiary ACE Endeavor Inc. signed a shareholders' agreement with CSEC and Greencore Power Solutions 3 Inc. to develop, construct and operate a photovoltaic (PV) solar power plant in Arayat and Mexico, Pampanga.

ACEN Corp. and subsidiary ACE Endeavor Inc. signed Thursday an agreement with Greencore Power Solutions 3 Inc. and Citicore Solar Energy Corp. to extend P2.3 billion in financing for the second phase of the Arayat solar project. ACEN said along with Endeavor, it signed the agreement with Greencore as the borrower for the 43.68-megawatt solar ...

As for solar projects, Apolaki Two Inc.'s 600-megawatt direct current (MWdc) Titan I solar power project in Pantabangan, Nueva Ecija and Greencore Power Solutions 2, Inc.'s 51.6MW Tuy Batangas 4 Solar Power Project have also been endorsed to the NGCP.
