

Who owns Energy Corporation of Kosovo?

Energy Corporation of Kosovo sh.a. (KEK sh.a.) is the main energy company in the Republic of Kosovo. It is vertically integrated and was corporatized at the end of 2005. MZHE prepares legislation and drafts strategies and projects.
