Leclanche's energy management software (EMS) is designed to integrate flexibly with multiple battery/inverter combinations. These include mix-and-match configurations with multiple vendors, subsystem software versions, battery management systems (BMS) and various power and energy ratings with a very high level of reliability and performance.

Further upstream, the company also made a recent swoop to acquire energy storage software specialist Demand Energy. On the 22MW project in Brandenburg, Joerg Muller, head of the board at ENERTRAG said it would help "play an essential role in safely phasing-out lignite in the state of Brandenburg".
