Who owns the Liechtenstein Global Trust?

LGT, originally known as The Liechtenstein Global Trust, is owned by the princely House of Liechtenstein through the Prince of Liechtenstein Foundation and led by its royal family members H.S.H. Prince Maximilian von und zu Liechtenstein (CEO) and H.S.H. Prince Philipp von und zu Liechtenstein (chairman).

Who is the CEO of Liechtenstein Group AG?

Constantin Liechtenstein becomes Chairman of the Liechtenstein Gruppe AG Supervisory Board and member of the Board of Directors of Liechtenstein Gruppe Holding AG. As a result, he is stepping down from his role as CEO of Liechtenstein Gruppe AG. Johannes Meran, currently CIO and Managing Partner, takes over as CEO of Liechtenstein Gruppe AG.

What does the Liechtenstein group stand for?
