The two islands have completely separate energy systems - the St Kitts Electricity Department is a government-owned utility company responsible for the generation, transmission and distribution of electricity on St Kitts. The Nevis Electricity Company is a public-private company that provides the same services on Nevis.

The introduction of battery energy storage systems (BESS) facilities will greatly enhance the island's ability to

integrate renewable energy into the grid, stabilise power supply, and reduce dependence on fossil fuels. While the exact battery chemistry in use has not been specified, the emphasis on BESS suggests a likely reliance on lithium-ion technology, which is ...
