

What are the major production systems in Bosnia and Herzegovina?

The largest production systems in this industry in Bosnia and Herzegovina are Meggle Bihać, Milkos Sarajevo, MI99 Gradačac, Eco cheese Puča Livno, Kupres Milch, Mlijekoprodukt Kozarska Dubica, Mljekara Livno, Poljorad Travnik, ZIM Zenica, etc. The meat processing sector is one of the most important and developed sectors in Bosnia and Herzegovina.

What is the metal industry in Bosnia and Herzegovina?

The metal sector in Bosnia and Herzegovina, along with primary metal production, is traditionally the strongest and most successful industrial and export sector, with an average of 34.2% of the country's total exports, which is a significant advantage over other export categories.

When did the automotive industry start in Bosnia & Herzegovina?

The beginnings of the automotive industry in Bosnia and Herzegovina were associated with manufacturing parts for Mercedes and then for Volkswagen. In BiH, in 1970, the TAS Sarajevo factory was established as a joint venture between Volkswagen and UNIS.

How did the economy of Bosnia and Herzegovina change in 1992-1995?

Regarding the conditions and factors of production, the most important changes in the economy of Bosnia and Herzegovina, in the period 1992-1995 (during the aggression on Bosnia and Herzegovina), occurred based on their permanent destruction from the face of the Earth or their permanent disabling for economical use.

How has the transition process accelerated in Bosnia and Herzegovina?

Since 2000, the transition process in Bosnia and Herzegovina has accelerated, largely due to monetary stabilization (low inflation, stable currency, low external public debt), price liberalization, and financial system reform.

Where did economic and social restructuring take place in Bosnia & Herzegovina?

These critical processes of economic and social restructuring took place depending on the general Yugoslav policy and circumstances, and for Bosnia and Herzegovina, in scope and especially in structure, very unfavorable and far behind the developed European countries with Western democracies.
