

What is Northvolt ett?

Just shy of the Arctic Circle, you'll find Northvolt Ett - a lithium-ion battery gigafactory that stands as Europe's first homegrown response to opportunities and needs of an electric world. The bankruptcy follows the cancellation of the Northvolt Ett Expansion development project in Skellefte, Sweden, as part of the new strategy launched in September to save the core business of Northvolt, the battery production that has started but has not yet managed to get off the ground as planned.

Does Northvolt still operate?

The company said it will maintain normal operations, fulfilling obligations to vendors and paying employee wages. Northvolt Ett, the flagship battery gigafactory in Skellefte, Sweden, and Northvolt Labs in Västerås, Sweden, will remain fully operational.

What is Northvolt doing with Altris?

Northvolt, which developed its sodium-ion cells in partnership with Altris, said that its focus is on the industrialisation of this technology and developing solutions for its integration into energy storage solutions for global deployment.
