

Who is Ormat Technologies?

Ormat Technologies, Inc. is an international company based in Reno, Nevada, United States. Ormat supplies alternative and renewable geothermal energy technology. The company has built over 190 power plants and installed over 3,200 MW. As of January 2021 it owns and operates 933 MW of geothermal and recovered energy based power plants.

Who is Ormat Energy?

Ormat is a provider of renewable energy technology based in Reno, Nevada. Established in 1965, the company designs, develops, builds, owns and operates geothermal and recovered energy-based power plants.

What is Ormat Energy Converter?

Ormat designs, manufactures, operates, owns, and sells geothermal and REG power plants primarily based on the Ormat Energy Converter - a power generation unit that converts low-, medium- and high-temperature heat into electricity.

Where is Ormat located?

Ormat's current 1,100 MW generating portfolio is spread globally in Kenya, Guadalupe, Guatemala, Indonesia, Honduras, and the United States. Ormat expanded its operations to provide energy storage solutions by leveraging its core capabilities, global presence, and experience in the energy market.

When did Ormat Technologies go public?

In 2005, Ormat sold its shares in the company. In 2004, Ormat Technologies completed an initial public offering on the New York Stock Exchange raising \$100 million. Ormat Technologies was founded in 1994 as a US subsidiary of Ormat Industries.

How many MW does Ormat generate?
