Who owns the shares of pzem?

Fifty percent of the shares of PZEM are held by the Province of Zeeland. The other fifty percent of the shares are held in varying percentages by a few municipalities in Zeeland. The final sale is still subject to a number of other conditions but will most likely take place on a date to be determined in early 2023.
