

Where is Baytex Energy headquartered?

It also holds interest in the Eagle Ford property in Texas; Viking and Lloydminster properties in Alberta and Saskatchewan; and Peace River and Duvernay properties in Alberta. Is Baytex Energy a risky company?

Baytex Energy Corp (NYSE:BTE) still holds a significant net debt of \$2.5 billion as of September 30, 2024, which may pose financial risks. The company is in the demonstration stage of development for the Pembina Duvernay, which may involve uncertainties and risks.

Why did Baytex buy Burmis Energy?

In April 2008 it completed a \$181 million takeover of Burmis Energy Inc, a Calgary-based oil and natural gas producer (72% of production was natural gas) that was nine times smaller than Baytex at the time. The deal gave Baytex control of the Seal heavy oil property in Alberta and increased daily production by 3,650 boe.

What is Baytex Energy Corp's ISS governance quality score?

When did Baytex buy Aurora Oil & Gas?

In June 2014 Baytex acquired Aurora Oil & Gas Limited, which led to its significant new position in the Eagle Ford shale oil play in Texas. In 2014 Baytex 52-week high was \$49.88 and its 52-week low was \$14.56. For fiscal 2016 total production was 69,300 US bbl /d, 8,260 m³ /d, flat to the year before.

Why did Baytex buy Ranger Oil Corporation?

Ed LaFehr, the President and Chief Executive Officer of the company commented that they are "facing unprecedented challenge due to the significant degradation and volatility in global crude oil prices." On February 20, 2023, Baytex announced that it had agreed to acquire Ranger Oil Corporation.
