One week later, Northvolt raises \$5bn non-recourse project financing, the largest green loan in Europe, for the expansion of Northvolt Ett, for its recycling plant Revolt Ett and to re-finance the \$1.6bn loan from 2020. Swedish battery manufacturer Northvolt has secured a \$5bn (Skr52.31bn) non-recourse project financing deal for the expansion of the first circular gigafactory in the country.. The money will be used to fund the expansion of Northvolt Ett, the company's primary facility in northern Sweden, and will also support the growth of its adjacent recycling plant, Revolt Ett.

Northvolt AB's subsidiary company, Northvolt Ett Expansion AB, filed for bankruptcy on October 8 following the suspension of its major expansion project in September 2024. This decision is directly related to the financial state of the subsidiary, which was tasked with managing the Ett expansion construction project.
