Will Exide Industries merge with EESL?

Exide Industries has also applied for regulatory approvals for the merger of its wholly-owned subsidiary Exide Energy Private Limited (EEPL) with Exide Energy Solutions (EESL) to bring all lithium battery business entities under a single roof.

Will Exide Leclanche merge with Exide Energy Solutions Limited?

The proposal to merge Exide Leclanche Energy Private Limited and Exide Energy Solutions Limited was announced last December. Exide Leclanche, branded as 'Nexcharge', is the business that arose out of the company's initial joint venture with Swiss battery firm Leclanché -- but which later became a 100%-owned Exide subsidiary.
