The ETA, which applies to short-term stays for tourism, study, or business, will be a requirement starting ...

A CARICOM National entering the Federation of St. Kitts and Nevis with a Skills Certificate should present the document to the Immigration Officer and will be granted six (6) months definite stay. The CARICOM national should then visit the Ministry of International Trade in St. Kitts to have the Certificate verified.
