Is Vietnam a good country for solar energy?

Vietnam leads the ASEAN region in both photovoltaic manufacturing and photovoltaic installed capacity. In terms of the solar energy potential, Vietnam is endowed with unique solar resources.

Does Vietnam have a wind power plant?

Vietnam has 8.6% of its land area with excellent potential for large-scale wind power plants, compared with 0.2% in Cambodia, 2.9% in Laos and 0.2% in Thailand. Because of this, Vietnam's wind power is growing rapidly. In May 2019, there were only 7 wind turbines connected to the grid in Vietnam, with an installed capacity of 331 MW.

The construction of the 26.15MW Rooftop Solar Project commenced in early 2022 and consists of 47,554 solar panels across more than 200,000 square meters of rooftop space. The rooftop solar facility is the largest in Vietnam and one of the largest in the entire Southeast Asia region.

Vietnam's solar industry is expected to grow significantly in the coming years. The government has implemented various policies to support the development of the solar sector, including providing incentives for solar power generation and promoting the use of solar energy in residential and commercial buildings.
