Lithium-ion batteries (LIBs) have become enormously attractive in recent years due to the significant growth of the electric vehicle (EV) market. The International Energy Agency (IEA) predicted a global battery market valued at \$360-410 billion in the next decade, with the global electric car market growing to 35% of total car sales by 2030 [1].

Western Sahara Resource Watch, a Brussels-based NGO allied to the independence movement, estimates that by the end of the decade occupied Western Sahara could be supplying half of all Morocco's wind energy and a third of its solar energy, much of it headed for Europe. Morocco insists that the territory is part of Morocco.

Export Finance Australia (EFA) has conditionally approved a EUR120m (\$126.8m) commitment for Vulcan Energy's phase one Lionheart integrated lithium and renewable energy project. This commitment is a part of Vulcan's debt financing process and follows a non-binding letter of support received in October 2023.

Morocco risks implicating other states by exporting Western Sahara energy, for instance to the EU. The EU has promised not to import green energy from the territory, but is unlikely the EU will be able to differentiate energy generated in Morocco proper and energy generated in the occupied territory, as it will pass in cables under Strait of ...

This has been a big year for King Mohammed VI. His government is harvesting major diplomatic wins--thanks to hardball tactics on migration. As Europe wrestles with migration and energy challenges, Morocco has masterfully leveraged its strategic position as a gatekeeper on these issues to gain international support for its controversial claims in Western Sahara.
